

Terms and Conditions for Blossom Easter Raffle 2021

Notification for winners:

We will contact the winners by text message/email and we will arrange delivery of items as per winners' requests via email (digital vouchers) or post. The entry data will only be used for the intended purpose.

Terms & Conditions:

These terms and conditions ("Terms & Conditions") set out are the basis on which you can participate in the Blossom Ireland Easter Raffle 2021 (the "Raffle"). By entering the Raffle you accept these Terms & Conditions in full and are supporting Blossom Ireland ("Blossom"). If you do not accept these Terms & Conditions, you should not enter the Raffle and you will not be eligible to win the Prizes (as defined herein). Entry is by purchase of a Raffle ticket only.

1. **RAFFLE PERIOD:** The start date for entries is 12th March 2021 at 3pm (IRE time) ("Start Date"). The closing date for entries is 5th April 2021 at 23:59pm (IRE time) ("Closing Date"). The winners will be revealed on Instagram on 6th April 2021 from 3pm and will be contacted by email by 9th April 2021. Entries received after the Closing Date will not be entered into the Raffle but may still be charged.
2. **TO ENTER:** To enter the Raffle, you need to purchase a minimum of one (1) Raffle ticket(s) through <https://www.idonate.ie/raffle/BlossomIrelandEasterRaffle>. Tickets prices are 1 Tickets = €5; 5 Tickets = €20; 10 Tickets = €35; 25 Tickets = €75.
3. **ELIGIBILITY:** Entry is only open to Blossom supporters based in Ireland due to the nature of the prizes.
4. If entrants are under 18, consent from a parent or guardian must be obtained prior to entry and the parent or guardian must agree to these Terms & Conditions in full. Winners may be required to be over 18 in order to claim their prize(s).
5. Employees of Blossom are not eligible to enter the Raffle.
6. No refund may be claimed for any expenses incurred relating to the use of a mobile phone or internet connection for the purpose of entering the Raffle.
7. **PRIZES:** Each winner shall receive such prizes as will be advertised and communicated to supporters via the website www.blossomireland.ie, and each eligible entry shall only be eligible to win one (1) prize, subject to paragraph 9 below.
8. Blossom reserves the right to substitute the Prizes (or any part of them) for a prize or prizes of equivalent or greater monetary value if this is necessary for reasons beyond its control. All costs and expenses not included within the Prizes are the responsibility of the winner(s).
9. **SELECTION OF THE WINNER(S):** The winner(s) will be picked at random from all eligible entries received between the Start Date and the Closing Date on the live prize draw.
10. The winner(s) will be contacted by text message/or email using the contact details provided after the Closing Date. If a winner cannot be contacted within a reasonable amount of time an alternative winner will be selected at random from the remaining eligible entries.
11. All prizes will be sent by email (digital vouchers) or post unless specifically arranged between winner and Blossom.
12. **PUBLICITY AND PERSONAL DATA:** Blossom will collect the personal details of the winner(s) for the purpose of carrying out and administering the Raffle only. More information about how Blossom handles personal data is available at www.blossomireland.ie.
13. Blossom reserves the right to withdraw or amend the Raffle or these Terms & Conditions if circumstances outside its reasonable control make this unavoidable.
14. Entries must be strictly in accordance with these Terms & Conditions. Any entry not in strict accordance with these Terms & Conditions will be deemed to be invalid and the Prize(s) will not be awarded in respect of such entry. Blossom reserves the

right to verify the eligibility of any entrant and to exclude any entries which it believes to be invalid or in breach of these Terms & Conditions.

15. Blossom decision is final in all matters relating to the Raffle (including the Prizes) and no correspondence will be entered into.
16. Except in respect of death or personal injury resulting from any negligence of MADRA, to the maximum extent permitted by law, neither Blossom nor any of its officers, employees or agents shall be responsible for (whether in tort, contract or otherwise):
 1. any loss, damage or injury to you and/or any third party or to any property belonging to you or any third party in connection with the Raffle and/or the Prizes (including the winner's receipt or use of the same), resulting from any cause whatsoever; or
 2. any loss of profit, loss of use, loss of opportunity or any indirect, economic or consequential losses whatsoever and howsoever caused.
17. **GOVERNING LAW AND JURISDICTION:** Please note that these Terms & Conditions are governed by Irish law. This means that your entry into the Raffle and any dispute or claim arising out of or in connection with it will be governed by Irish law. You agree that the courts of Ireland will have exclusive jurisdiction in connection with any such dispute or claim.
18. **SPIRIT OF THE RAFFLE:** If you attempt to compromise the integrity or proper operation of the Raffle by cheating or committing fraud in any way, Blossom reserves the right to render your entry invalid, seek damages from you and ban you from participating in any of their future raffles and/or competitions.
